### **COMMITTEE REPORTS**

**MR. S. SHURGOT:** being that this is the first meeting of the year and having just been elected President, there are no committee assignments. I would ask the Mayor to give the public safety report.

**MAYOR G. JAKUB:** for the month of December Eastern Area Pre-Hospital Service responded to 52 calls and had 38 transports. Their average response time for emergencies was 6.3 minutes and for non-emergencies it was 10.3 minutes. For the fourth quarter of 2015 they responded to 160 calls and had 121 transports. Their average response time for emergencies was 6.9 minutes and for non-emergencies it was 9.8 minutes. For the year of 2015 they responded to 630 calls and had 428 transports. Their average response time was 7.0 minutes for emergencies and 9.4 for non- emergencies.

**ENGINEER – S. GLENN:** the 2015 CCTV Sewer Project will begin the second week in February, weather permitting. Insight Pipe is the contractor for this project.

The county has not yet responded to our request for additional funds, however, their engineers were on site last week to inspect the slide area. One lane has been opened after installing larger concrete barriers.

We did submit an application for a grant for cameras at the dump site. Nothing is going to happen until spring.

- MR. J. THOMAS: we authorized up to \$5,000 for the barriers, what was the total cost.
- **MS. S. SMITH:** the cost for the barriers was \$2,160 and for the delivery it was \$1,000. We had to use two different trucking companies because the county could not wait for them to make another trip to New Castle.

**SOLICITOR – G. EVASHAVIK:** I reviewed the cooperation agreement for the C.I.A.C. and the Keystone Communities Program. Wilmerding is taking the lead on getting a \$25,000 grant for this study. This resolution enters into an agreement with DCED and the C.I.A.C. I am recommending that the resolution be approved so that we can move forward with this study.

We have reviewed the paperwork for a \$200,000 loan for paving. We need your C.P.A. to prepare a debt statement so that we can proceed. There is also an ordinance and resolution that would need to be passed.

## K. PETERSON / S. SMITH TO ADVERTISE THE ORDINANCE FOR THE \$200,000 LOAN. MEMBERS VOTED APPROVAL, 6-0.

- **MR. J. THOMAS:** in the resolution it says the Community Improvement Action Committee, it should read Community Improvement Advisory Committee.
- S. SMITH / K. PETERSON TO PASS THE RESOLUTION, WITH CORRECTIONS, FOR THE KEYSTONE COMMUNITIES PROGRAM. MEMBERS VOTED APPROVAL, 6-0.

#### **FINANCE**

- J. THOMAS / REV. D. REEVES TO PAY ALL THE APPROVED BILLS. THESE ARE THE REGULAR NORMAL BILLS WE RECEIVE EACH MONTH.
- MS. S. SMITH: what are we going to do with the high water bill?
- **MR. J. THOMAS:** I don't know what we can do, if anything.

### **MEMBERS VOTED APPROVAL, 6-0.**

- J. THOMAS / S. SMITH TO TRANSFER \$40,000 FROM THE PLGIT SEWER FUND TO THE GENERAL FUND TO REPAY A LOAN FROM 2009. MEMBERS VOTED APPROVAL, 6-0.
- **MS. S. SMITH:** are we going to apply for a tax forgiveness loan.
- MR. J. THOMAS: we will use this money first.

#### **OLD BUSINESS**

**MS. S. SMITH:** are we or are we not going to rent the room out downstairs. The Eastern Star ladies come every third Saturday of the month. We can discuss this further after the committees are formed. Also, the key pad on the door downstairs is not working. There is a key lock built in, can we switch over to that.

### **NEW BUSINESS**

**MS. S. SMITH:** the new Magistrate asked us if we have community service. Greg is looking into this to see if we can use them in our public works department.

- **MS. P. SHURGOT:** a resident from the borough approached me and asked if he could fix up the entrances to Wilmerding so that he can earn his Eagle Scout Badge. We can discuss this later after the committees are formed
- MR. S. SHURGOT: can we have a "G" made at a metal shop or have the whole sign redone.
- **MS. S. SMITH:** the fire department asked us that if anyone is interested in seeing what they have they can go downstairs and the firemen will take them on a tour.
